With the home market booming, residential appraisers are under increased pressure to support their opinions of value. This book includes examples that illustrate common scenarios encountered in residential appraisal practice and presents definitions of key terms to help the reader understand the important concepts presented.

Recent Florida Legislation Passed

Pinellas Property Appraiser Mike Twitty has again successfully championed legislation for Florida homeowners. Two bills were passed during the 2021 session that have set the stage for Florida voters to approve a Constitutional Amendment that would allow residential property owners to voluntarily elevate their property above Base Flood Elevation (BFE) within the Special Flood Hazard Areas (SFHA) without impacting their Assessed Value from the new construction cost. This legislation incentivizes investment of private capital to proactively elevate residential properties out of harm's way.

Key elements of the legislation follow:

- May elevate existing structure or rebuild up to 110% of total square footage (excluding grade level parking/ storage/access areas) without a change in Assessed Value
- Must lie within a SFHA (A or V Zone) with lowest living floor below Base Flood Elevation (BFE)
- Structure cannot be condemned
- May not undergo a change of use
- Applies to both Homestead and Non-homestead Residential Properties (Up to 9 units)
- Assessed Value resets to Just/Market Value upon sale/transfer

Effective Jan 1, 2023, if approved by at least 60% of Florida voters. Find out more info on this ballot initiative at www.pcpao.org.

The Appraisal Institute is staying abreast of the many meetings that are occurring on Capitol Hill and within the agencies focusing on the topic of bias and diversity in the appraisal profession. It is important that we have a seat at the table as these issues are being discussed.

On July 29th, HUD held a virtual event entitled "Advancing Equity in the Home Valuation Process." The purpose of the event was to discuss how bias in the home valuation process and the lack of diversity in the appraisal overall contributes to racial wealth disparities. Several speakers presented on the topic, and stakeholder feedback is anticipated going forward. HUD Secretary Fudge discussed President Biden's recent charge to HUD to lead a new Interagency Task Force on Property Assessment Valuation Equity, or PAVE.

Rest assured the AI Washington D.C. staff will keep the membership informed on this increasingly hot topic.

In Memoriam—A Tribute to Henry c. Entreken, MAI, by Mike Twitty, MAI

I don't think there is an appraiser in the greater Tampa Bay area that won't miss the friendly smile, laugh and southern gentlemen charm of our very own **Henry C. Entreken**. He has been a welcome and ever-present fixture at our chapter meetings for the past several decades. Along the way Henry was a staunch advocate of the appraisal profession, preaching the value of education, and the importance of collaboration and mentoring. Through his instruction, writing over 35 articles in professional journals, and extensive speaking on appraisal subjects, he became recognized as an expert in his field.



Henry's journey as an adult began after graduating from Emory University in 1951. He taught elementary school for a year prior to being drafted and serving his country during the Korean War (1952-1954). However, being the careful and diligent man that he was, Henry made sure to woo and win the hand of Annie Doris Cosby from a competing suitor and put a ring on her finger before leaving for Army bootcamp. They celebrated their 69th wedding anniversary in March.

After completing his military service and returning to Doris in Atlanta in 1954, Henry was ready to start his career. Looking over job want ads in the newspaper one in particular caught his eye. It read something like this: 'Wanted: Trainee Appraiser in Atlanta area for Mutual of New York (MONY). Job requirements include some travel and an ability to hold your liquor.' Henry got the job, and his appraisal career was underway. Henry was fascinated by the appraisal industry and quickly became involved in the American Institute of Real Estate Appraisers, serving as President of the Atlanta Chapter and receiving his MAI designation in May of 1961.

His work experience with MONY led to developing various industry relationships. One of these relationships resulted in Henry moving their now family of four to Pinellas County in 1967, where he joined the Glen E. McCormick Company. Here Henry became heavily involved in the commercial mortgage banking business, working closely with Dwight McCormick and Jesse Stroud. While diversifying the company's services, Henry brought in Harold Robertson to set up a commercial appraisal department. During this time Henry became involved in Florida Chapter 2 of the AIREA, serving as President in 1982.

A few years later, Harold convinced Henry that they should head out on their own due to Henry's passion of the appraisal industry and a changing regulatory climate, forming Entreken Robertson Associates, Inc. in 1985. They brought their first commercial associate, Jeff Boyle, on board in 1988 and then added Mike Twitty in 1990. Tom Hockensmith came on board in 1991 to start a residential department. A new partnership was formed in 1993 between Henry, Jeff, Mike and Tom and the firm became known simply as Entreken Associates, Inc. Together this core group worked, collaborated, laughed, and learned from each other for more than 25 years. Always taking some time to celebrate and enjoy shared fellowship by bringing their work and home families together.

Henry was the first recipient of the Henry C. Entreken Lifetime Achievement Award, which was established by the Chapter in his name and is awarded to chapter members that exhibit exemplary dedication and service. He retired in 2011. An avid fan of the Tampa Bay Rays, he attended games since the inaugural season, as well as being a dedicated fan of football and hockey. Henry attended services at First Baptist Church and First Christian Church in Largo, Pasadena Presbyterian Church, all where he taught Sunday School classes, and Pasadena Community Church.

Henry was a true southern gentleman, with a humble spirit and wry sense of humor. He and Doris loved to travel and saw much of the world together. Fashionably dressed in his suspenders with a ball cap on his head, Henry was always ready for a lively discussion on any topic. He was an avid reader, movie goer, and he loved a good meal, always accompanied by a cold Coca-Cola. A wonderful husband, father, grandfather and friend, Henry will truly be missed every day. He is survived by his wife, Doris; sons, Eddie (Debbie) and David (Vicki); granddaughter, Sarah Entreken; and step-grandchildren, Zachary and Casey Anderson.

Synchronous Designation Education

Check out AI's synchronous course, "<u>Advanced Income Capitalization</u>," Aug. 2. This course builds on topics covered in the "General Appraiser Income Approach/Part 1" and "General Appraiser Income Approach/Part 2" courses. It introduces additional topics that a seasoned general real property appraiser can expect to meet in everyday practice. The course features a limited review of material covered in the previous income courses to maximize the time available for advanced topics.

"Advanced Concepts and Case Studies" will begin on Aug. 16. This 40-hour course synthesizes basic and advanced valuation techniques taught in previous courses and addresses consistent treatment of the three valuation approaches for various valuation problems. Case studies teach participants how to address common but complex appraisal issues, including a leased fee not at market rent, a proposed property, a property in a market not at equilibrium, and a subdivision. The course emphasizes the need to test the reasonableness of conclusions in an appraisal.

CE Requirements

Candidates and Practicing Affiliates must complete 70 hours (350 points) of continuing education for every five-year cycle. Designated members must complete 100 hours (500 points) of CE every 5-year cycle. The points system offers an incentive to individuals who attend advanced education. Al will now reward individuals who take and pass exams. The system's tiered point structure allocates higher point values to courses and seminars defined as advanced education. For more information, visit the Al website.

Generally, 1 hour of CE = 5 points (1% of 500 points) or more. This formula is also used for education taken outside of AI, which members can add on their own by logging onto the website and clicking: Add Credit to My AI CE Log. USPAP and Business Practice & Ethics are each valued at 35 points.


