On the Hill

Legislation for Transmission Facilities Contains Important Eminent Domain Language

On Aug. 5th, Bill <u>S. 2651</u> was introduced to Streamline Interstate Transmission of Electricity Act, legislation would establish a procedure for the siting of certain interstate electric transmission facilities.

Legislation includes a provision for **condemnation** that allows landowners to pick a representative to value their property in accordance with the USPAP before an offer of just compensation is extended. Additionally, a landowner's representative will have the opportunity to accompany an appraiser during the inspection. (Al supports this provision.)

A similar provision can be found in <u>S. 641</u>, the Landowner Fairness Act, legislation that was introduced in March.

Both bills remain in the committee process, and no timetable for Senate review has been established.

Legislation Targeting Conservation Easement Abuse Part of House Reconciliation Package

The Charitable Conservation Easement Program Integrity Act, bipartisan legislation that targets abusive conservation syndications, will be included in the budget reconciliation package that is being finalized by the House Committee on Ways and Means.

HR 4164/S 2256 would limit tax deductions for qualified conservation contributions made by certain partnerships if the amount of the contribution exceeds 2.5 times the sum of each partner's relevant basis in the partnership. This limitation also applies to other pass-thru entities, such as S corporations.

In the Agencies - PAVE

Interagency Appraisal Task Force Convenes; Defines Scope and Objectives
The task force for the Property Appraisal and Valuation Equity Interagency, known as
PAVE, held its first meeting Aug. 5 to define its scope of work in preparation for creating
a final action report due within 180 days. President Joe Biden created the task force via
Executive order to address "inequity in home appraisals."

PAVE is expected to finalize a report of findings and recommendations by early next year. The AI Washington staff is watching this development and listening to the discussions. We must have a seat at the table and an ear to the discussions. AI will report the progress as it occurs.

ASC Offers Additional Grants to States for Improvement, Expansion of Appraisal Processes

The Appraisal Subcommittee at its Sept. 15 meeting approved publication of a Notice of Funding

Availability that provides an additional \$3.3 million for "State Appraiser Regulatory Agencies Support Grants." These funds are in addition to the \$3.336 million that was made available via a NOFA published last year.

Approximately \$625,000 was awarded to eight states as part of the first round of funding, according to an ASC document. For more information see ASC's grants programs.

PAREA – Multiple states consider whether to allow PAREA to Satisfy Experience Requirements

Further, 15 states have fully adopted by reference the AQB's Real Property Appraiser Qualification Criteria, known as RPAQC. PAREA is part of RPAQC.

Because <u>PAREA</u> is part of Real Property Appraisal Qualifications Criteria (RPAQC), it should be permissible for aspiring appraisers in the states that approved PAREA to satisfy their experience hour requirements in a manner equivalent to how others satisfy experience requirements through the supervisor/trainee model.

Other National News

Al Board of Directors Adopts Strategic Plan

Taking a big step forward, the Appraisal Institute Board of Directors adopted a Strategic Plan at its Aug. 12-13 meeting in Orlando, Florida.

The Board's strategic planning process included input from AI professionals who responded to surveys regarding membership needs.

A key component of the Strategic Plan is an updated Mission Statement: Our mission is to empower valuation professionals through community, credentialing, education, body of knowledge and ethical standards.

Another element of the Strategic Plan is Core Values. The Appraisal Institute is:

- Dedicated to excellence, professionalism, ethics and integrity.
- Committed to leadership and innovation.
- Devoted to an inclusive and welcoming community.

Additionally, the Strategic Plan includes four Goals:

Attention Candidates for Designation

CE Requirements

Candidates and Practicing Affiliates must complete 70 hours (350 points) of continuing education for every five-year cycle. Designated members must complete 100 hours (500 points) of CE every 5-year cycle. The points system offers an incentive to individuals who attend advanced education. Al will now reward individuals who take and pass exams. The system's tiered point structure allocates higher point values to courses and seminars defined as advanced education. For more information, visit the Al website.


Generally, 1 hour of CE = 5 points (1% of 500 points) or more. This formula is also used for education taken outside of AI, which members can add on their own by logging onto the website and clicking: Add Credit to My AI CE Log. USPAP and Business Practice & Ethics are each valued at 35 points.

If you have not met minimum designation progress, do not risk losing credit for the requirements previously completed.
